The land and some original buildings which are today part of Tulane University in New Orleans were already in existence. However, they were known as University of Louisiana which was a public institution. However, when Louisiana's Constitution of 1868 extended the right of public education to blacks, this created a problem because it would no longer be possible to exclude blacks from the University of Louisiana. Therefore, the University of Louisiana was privatized and the name changed to Tulane University so blacks could be legally excluded. Paul Tulane hated blacks and was a segregationist. The privatization allowed Tulane to embrace "cherished southern traditions". [1]

However, later Joseph Merrick Jones (August 20, 1902 – March 11, 1963) became president of the board of Administrators of the Tulane Educational Fund. In early 1963 he announced that Tulane would admit black students, beginning in the spring semester. He and his wife were killed when fire swept their home in Metairie, Louisiana soon after. Arson was suspected but never proven. However, his decision stood and Tulane began to admit black students for the first time. [2]

#### **TULANE JOINS THE IDA**

At the end of World War II, the United States acquired certain new - shall we say - "enhancements" to its abilities and also a new general mandate which we know today as the "New World Order". The primary enhancement was the secret importation of almost ten thousand high level Nazi doctors, engineers and other assorted highly gifted scientists under "Operation Paperclip". These people were all SS members who were guilty of hideous war crimes and would have surely been convicted at the Nuremberg trials. However, the US protected them, gave them new identities and placed them in high positions. The possible reason for this was that the US recognized that the Nazi people were smarter than they were. The Nazi scientists created NASA and also helped greatly in the creation of the new CIA (which evolved from the OSS) as well as the NSA. However, philosophically, they remained Nazis and that is why, today, we live in a police state similar to that created by the East German Stasi.

The government's original attempts to subvert higher education for their covert agenda began in 1939 and is documented in the book "Cloak & Gown" [3]. However, these programs were to be greatly expanded with the passage of the National Security Acts of 1947 and 1949 which gave the government new authority to declare anything it wanted secret and kill anyone who dared to disclose those secrets. With the "shadow government" now legally authorized, it was time to move full steam ahead with projects which (it believed) would never be revealed to the general population (black projects).

In April 1956, IDA (Institute for Defense Analyses) was incorporated as a non-profit organization. [4] In 1958, at the request of the Secretary of Defense, IDA established a division to support the newly created Advanced Research Projects Agency (ARPA), later renamed the Defense Advanced Research Projects Agency (DARPA). However, its reach quickly expanded to other government agencies and organizations. Today, the IDA has a direct pipeline to the highest levels of both the admitted and shadow governments of the United States. The five initial members in 1956 were Caltech, Case Western Reserve, MIT, Stanford and Tulane.

How, you may ask, was Tulane University invited to join this very exclusive club of "Spooks". Well, the primary contact between Tulane and the IDA in the 1960's was Tulane's president, Herbert Longenecker. We know this to be a fact because it was disclosed and confirmed by one of Tulane's executive level staff, Dr. Lee Hoffman. Detailed internet records on Longenecker are scarce and may have been scrubbed. However, we know his college education was in biochemistry and you will realize the relevance of this later in this report. This article [8] written at the time of his death is still available.

#### THE KENNEDY ASSASSINATION LINKS

Tulane University was barely mentioned during the Kennedy Assassination investigation. However, as we shall see, many individuals identified as being associated with Mr. Kennedy's assassination were somehow linked to Tulane University.


However, before we get into those goodies, let's go over one of the reasons the government wanted Kennedy gone which is rarely discussed. Kennedy became friends with Timothy Leary and took LSD. This means, as we all should know by now, that he had experiences with the other dimensions, experienced "cosmic consciousness" and likely was able to open his third eye. This changed his core philosophy to "make love not war". Since the US economy is based upon constant, unending war, the military - industrial complex simply could not tolerate a commander-in-chief who advocated peace. The US has been at war 93% of its history [5]. Clearly, Kennedy had to go. William Cooper [6] reports he saw the top secret report from the NSA which certified Kennedy as "a threat to the national security" and thus "legalized" his assassination.

Many serious investigators have quite literally dedicated their lives to uncovering the truth about the assassination of Mr. Kennedy. Today, there are no secrets left. All we will cover in this brief discussion are the links of some of the main "players" to Tulane University. The easiest way to do this is with some screen shots from the documentary [6] [L1]. #### **MARY SHERMAN**

In this brief summary we will mainly draw on material in [7].

When the US government realized that everyone given any of the polio vaccines had also been infected with the sexually transmitted monkey virus known as SV-40, they began to quietly panic. SV-40 causes cancer in humans and they knew an unprecedented epidemic of cancer would occur. Also, since SV-40 is sexually transmitted, all future generations would be infected even though they never received the polio vaccine.

So, originally, there was a crash program to try to stop this. The government installed a then top secret five million volt linear particle accelerator at the US public health service facility in New Orleans. Many researchers used this device for various projects. Scientists generally do not talk to "ordinary" people whether or not they have been sworn to secrecy so the existence of this device remained secret until exposed - many years later - by Edward Haslam.

Although the original project was to cure cancer, the focus quickly changed to causing cancer and weaponizing cancer. The original motive was to kill Cuban President Fidel Castro.

A nineteen year girl named Judyth Baker did a high school science project on cancer. She was able to cause cancer cells to grow faster than had been previously achieved. News travels fast and Alton Oschner went to see the young girl, offered to get her immediately into Tulane Medical School

(bypassing pre-med requirements) and brought her to New Orleans. Judyth met Lee Oswald "accidentally" in the downtown post office (70113 sort facility) and became his mistress never realizing that Oswald, a government agent, had been assigned to protect her.

Judyth's cancer secret was to infect something with cancer cells and then expose that to radiation which resulted in rapid growth. Apparently, no one had guessed that before so this discovery was revolutionary.

Because of issues with Cuba, the main focus now was to weaponize cancer as opposed to curing cancer. However, Judyth, being young and not realizing the true nature of the United States, was unaware of this. When she learned that her techniques had been used to deliberately kill a patient at East Louisiana Hospital (mental hospital), she was totally disillusioned and wrote a note to Alton Oschner expressing this. He was not pleased. He warned the young girl that she was "expendable" and that he could have her killed at any time. Her future potential career was immediately ended and - fearing for her life - she went into hiding until she finally told her story to the History Channel years later. However, her relationship with Oswald continued until he was killed. Oswald did not kill Kennedy.

Mary Sherman ran the project. Late at night, she would take cancer samples to the secret linear particle accelerator to be, basically, "sliced and diced". Oswald was trained to handle weaponized cancer and was to deliver the lethal dose to Cuba to kill Castro. David Ferrie was doing experiments so crazy that neither Tulane or Oschner would let him do them in their facilities. So, he rented two apartments in New Orleans. Here, rats were implanted with electrodes and connected to car batteries in another project to weaponize cancer.


Things began to unravel. Oswald never made it to Cuba. The Cuban missile crises was in full swing. The government decided to send in "cleaners" to erase all evidence. They connected the five million volt lead of the particle accelerator to the on/off switch knowing that Mary Sherman would show up at three AM to use the machine. Almost half of her body was literally vaporized when she touched the switch. However, the high voltage did not cross her heart so she was still alive. A cover up was needed. The cleaners took her back to her apartment, stabbed her a few times and started a small fire. The complete police report is still secret to this day. Haslam sued and got some of it. The FBI took her address book and redacted one name. The redacted name is, reportedly, "FERRIE".

Oswald was killed by Ruby. Ruby was killed by using Judyth's technique of injecting him with cancer cells and then leaving him exposed to radiation for about a half hour. David Ferrie "mysteriously" had a cerebral hemorrhage which was ruled "natural". If you saw the old sci-fi series "The Invaders", you might come to a different conclusion.

Now, everything had been "cleaned" - everyone was dead and the evidence destroyed. The particle accelerator was quietly disassembled and taken away. The land occupied by the US public health service became part of the New Orleans Adolescent Hospital (mental hospital). It is now abandoned.

#### THE BIOWEAPONS LAB

This is an aerial picture [L1] of Tulane University's 500 acre Level 3 bioweapons lab in Covington, Louisiana. This is a top secret installation. Access control uses iris scanners. Obviously, they don't give guided tours. This brief investigative report by The Advocate - a Baton Rouge, Louisiana newspaper - [9] sheds some light on this facility. It was prompted by the "accidental" release of one of the pathogens studied there. The lab stays in constant contact with the central US Bioweapons lab at Ft. Detrick in Frederick, MD. Bioweapons protocols require that all bioweapons *must* have an effective antidote. In previous cases where the Tulane scientists were unable to develop such an antidote, agents from Ft. Detrick immediately showed up to confiscate all samples of the pathogens. The official story that the Ft. Detrick facility was closed in 1969 is reportedly a lie. Reportedly, it not only never closed but was expanded. Reports of the closure appear to be propaganda.







Notice that this high security installation in basically the middle of nowhere is adjacent to a "christian" school. Why would you want any facility with innocent people - especially children - next to a top secret bioweapons lab. Well, if you watch the you tube videos by retired FBI agent Ted Gunderson on Satanic ritual child abuse and "christian" schools used as a cover, you might be able to guess what could be happening here.

The apparent function of this facility is to look for pathogens which are present in primates but cannot be easily transferred to humans and then genetically modify these pathogens to create new diseases against which humans have no natural defense to be used by the US government to kill selected target populations.

#### **MK ULTRA I**

Disclosures from the Church Commission list three facilities in Louisiana as participants in the top secret MK Ultra mind control project which ran from the 1950's through the 1970's. These facilities were Louisiana State University (LSU), Angola State Prison and <u>Tulane University</u>.

We are calling this MK Ultra I because MK Ultra II has just gotten underway in New Orleans with the opening of a huge medical complex to replace Charity Hospital where many MK Ultra I experiments took place. Charity Hospital was shared between Tulane University and LSU. The new sprawling facility is to be operated by LSU and the Veterans Administration (VA). Reportedly, it will be the facility for all covert human experiments for North America. Remember, the concepts of national borders and citizenship only apply to the slave populations. At the higher levels of government, all the "elite" cooperate. The code name for this new project is reportedly MARATHON. However, the government changes code names and code words frequently so there is no guarantee of this.

During the original MK Ultra project, Tulane's lead experimenter was Dr. Robert Heath, director of psychiatry. He is sort of a "rock star" in the medical community and his exploits are frequently cited in medical literature. Heath - deceased now - holds the worlds record for the doctor who implanted the most electrodes into the brains of human test subjects. It is doubtful that anyone will ever break his record.

Once exposed, Tulane first claimed it had destroyed all the records on its MK Ultra involvement. Later, when it was sued after hurricane Katrina, it changed its story and claimed it had records but "they must

have floated away during the hurricane" and so it could not find them. The projects we know about generally all centered around implanting electrodes in people's brains to see what reaction electrical stimulation of specific areas would produce. They obtained many of their "test subjects" from Angola State Prison. Reportedly, they were all black men.

#### **TULANE'S SECRET RADIATION EXPERIMENTS ON CHILDREN**

The information for this section was provided by Michael Traina, a psychologist working at Southeast Louisiana Hospital in Mandeville, Louisiana. Traina states he has direct knowledge of these events.

This state mental hospital - now privatized - had a "children's unit" where young kids whose parents claim were "disobedient" were held prisoners and drugged. Traina states that, periodically, some of the kids were told that they would be taken on a "field trip". They were taken to Tulane University's bioweapons lab in Covington, Louisiana. Here, they were placed in a confined area "to play". The staff left and the area was flooded with radioactive material of some type. Then the kids were taken back to their cage at the state hospital where they were covertly observed. These "field trips" were repeated at regular intervals.

This appears to be one of the 149 MK Ultra subprojects which remain undisclosed and undocumented. However, it is documented that the US government exposed unsuspecting people to radiation and secretly injected people including pregnant women with radioactive substances [12]. This project reportedly took place during the same time as the other projects which have now been publicly exposed. This one remains classified.

#### **TULANE'S EXPERIMENTS ON GAY MEN**

Tulane's Dr. Heath had a project - presumably a MK Ultra subproject - to change gay men into straight men. At that time, being gay or lesbian was considered a mental illness and you could be taken away for "treatment" against your will if detected. Doctor Heath's project - which is cited today in many medical reference books and is widely known - involved taking gay men, implanting electrodes in their brains designed to "stimulate pleasure centers" and then locking the men in a room with female prostitutes to see if they could be "reprogrammed" to want sex with women. However, the experiments were not successful.

At Tulane University, the campus police (called "greenie pigs" by the students) hid in the bathrooms looking for gay male students. Those found were taken into custody and "disappeared". We never learned what happened to them.

Because of this and other experiments by different researchers, it was eventually concluded that sexual preference could not be changed. Therefore, reluctantly, the American Psychiatric Association delisted

homosexuality and removed it from its catalog of mental illnesses known as the DSM.

Gays and lesbians should realize that the only reason they are free today is that all the various conversion experiments failed. If any had succeeded, the government would have used its arbitrary arrest authority under mental health laws to arrest all gays and lesbians and force them to undergo conversion. It is only because the experiments failed that you are free today. Things could have gone the other way so be thankful that they did not.

#### THE BLACK SITE PRISON

Information for this section was supplied by Cecile Martin, an employee at the Tulane University Hospital at that time. When the elevator stopped on the seventh floor, all that was visible was prison bars. These were real jail house bars with a real jail house locked iron gate. Cecile learned that this area was called "secure bedrooms". She did not have clearance to enter this area. Apparently, this is where Tulane University was holding the people who would later be experimented to death in some MK Ultra type project. A trip to the seventh floor appears to have been a one way trip.

Reportedly, the black site prison no longer exists at this location and may have been moved to some undisclosed location.

#### TOTAL CONTROL OF THE PRESS

Tulane University is in total control of the press in New Orleans. All they are allowed to report about Tulane is activities relating to their football team. Only in very exceptional circumstances can anything else be reported. Regarding athletic scholarships, no current information is available, however, we know that, in the period of the 1960's, the kids getting athletic scholarships did not even bother to go to class. One day, a kid I had never seen opened the door while a class was in session. The professor obviously recognized the kid and started telling him how he missed all the exams, never turned in work, etc. In the middle of the professor's comments, the kid said simply, "Athletic scholarship". Then he left the room and slammed the door. I never saw him again. When professors turn in failing grades on athletic scholarship kids, they are simply changed to passing grades before being officially recorded. Dr. Lee Hoffman once commented to me that the degree athletic scholarship students eventually receive is "payment for services rendered".

Michael Traina, a psychologist, was aware of the experiments Tulane had done during the MK Ultra project. He wanted to find and interview survivors of Tulane's experiments. However, at that time, there was no internet. The only way to communicate a message to the general population was to put a notice in a local newspaper. Traina sent his request - as a paid advertisement - to all the local New Orleans papers. However, in all cases, his ad and uncashed check were returned and no paper would run his request. No one dares to say anything negative about Tulane. Anyone in the news business knows

about Tulane's "special" relationship with the US government and no one wants their careers destroyed or, worse, to be "disappeared". So, they remain silent.

#### EBOLA BIOWEAPONS LABS IN AFRICA

Now, we wish to discuss some very serious current events. The source material for this discussion is [10]. The Ebola outbreak was in three African countries. They were Guinea, Liberia and Sierra Leone. Strangely, each of these countries had a secret US research lab. Also, perhaps not so strangely, these countries were not signatories to the Bioweapons Treaty. There would be no reason for third world countries with little technology and certainly no desire to make bioweapons to be a party to the treaty. However, the US *is* a signatory to the treaty and so - theoretically - is not supposed to be making bioweapons on its soil. However, if the US makes bioweapons somewhere else - in some country which has not signed the treaty - it can say technically it has done nothing illegal.

Now, in these labs were scientists from Tulane University. Therefore, it is pretty obvious that Tulane University played a part - perhaps a very major part - in the ebola outbreak.

Let's briefly go over some history. Everyone knows - or should know - that the United States has a habit of going into other countries and simply taking any resources that country may have that it covets by any means necessary. They have been doing this consistently at least since the end of W.W.II. Now, the African continent has mineral wealth and lots of fertile land which could be used for factory farms. Unfortunately, it is also inhabited by its indigenous people. Of course, so was the land which is today the United States. The US exists because it stole the land and killed the indigenous population. So, if the native population of Africa were to "mysteriously" die, the land would be empty and the US corporations could quickly move in, rape the place of anything of value and use the rest for factory farms, all the time protected by the US military which is already there.

Reportedly, the original plan to do this involved using the designer virus AIDS. Scientists are smart but generally lack common sense. They neglected to consider the fact that this population generally begins to reproduce at an early age. Consequently, even though many are now infected with AIDS and will eventually die as a result, before that happens they will produce many children. They will also be infected but they will live long enough to also have kids before they die. Therefore, the original top secret plan to depopulate Africa failed.

However, the new depopulation plan using weaponized ebola cannot fail because everyone can be exterminated quickly. The ebola release of the new weaponized variety could have been accidental but, more likely, was a test run. Notice how the US President immediately sent in the military. What are they going to do - shoot the virus? They were there to protect the secret labs and the scientists in case people began to figure out what really happened.

US corporations want that land. They know exactly where all the resources are. And, they are ready to

move when the order is given to exterminate the indigenous population.

#### RETIREMENT HOME AND SAFE HOUSE FOR SPOOKS

During the 1960's, there were various disturbances on college campuses mainly concerning the Vietnam War. Tulane had a few "sit ins" and stuff like that. The protesting students demanded that the Tulane President, Herbert Longenecker, respond to their concerns. He did respond. His response was - and this is a direct quote - "I am the President of this university and student affairs are not my concern." Well, well - then what are your concerns. Could they possibly be things like "Is Castro dead yet?", "All hell would break loose if anyone ever learns about MK Ultra.", "Hope everything goes OK with the Kennedy assassination" or "Make sure everything about Mary Sherman is covered up".

You see, the students, in reality, are just "window dressing" so that anyone who casually looks at Tulane will think it is just another higher education institution. It is not. If you start looking below the surface, you will find stuff that will blow your mind.

In the first place, the Tulane campus has special status. It is comparable to the land occupied by a foreign embassy. Tulane is in New Orleans but the New Orleans police are forbidden to enter. Only a few specially selected New Orleans police - called "liaison officers" - are allowed to enter. Tulane students - at least in the 1960's - could not be arrested. It is almost like diplomatic immunity. No matter what they may do off campus, the New Orleans police are only allowed to return them to Tulane - nothing more. There is a reason for this. Not all Tulane students are actually students. Some are foreign operatives and, for them, the Tulane campus is a safe house. No one can bother them there assuming you could identify them at all. They just "blend in" with the "ordinary" students who are clueless.

Much of the Tulane faculty could be best described as "retired government spooks". Jim Letten, who resigned during a scandal as US Attorney, is the latest to "join the club" [11]. Many faculty - especially in the sciences - are retired from the government and hold top secret or "Q" security clearances. The tulane police also need security clearances since they have free access to the campus and might see something. Consequently, this is a safe environment for insiders where they are free to converse with friends on subjects that most people have no idea even exist.

So, considering all this, would you benefit if you enrolled in Tulane as a student. Well, basically, people come in two main categories based upon their desires. There is STS (Service to Self) and STO (Service to Others). If you are in the STO group, you need to find another university. Tulane is for those seeking to become one of the elite - you know, those "exceptional" people who could not care less about those "ordinary" people. STO people have a conscience and respect human life. Tulane does not. Judyth Baker learned that the hard way and almost lost her life. You can avoid that problem by going somewhere else. Leave Tulane to the "spooks"!
