UNDERSTANDING THE MEDICAL SYMBOL



This is the medical symbol. It is Satanic and refers to mastery of what is known as the "Hermetic Arts" [1].

BRIEF HISTORY OF ALLOPATHIC MEDICINE

Allopathic medicine may be best described as an approach to disease based upon ignorance. Originally, "doctors" refused to wash their hands because the microscope had not been invented and they did not believe that germs existed since no one had seen a germ. They even continued to resist after the microscope proved germs existed calling it "quackery". Consequently, many "patients" died needlessly.

Any licensed doctor (you don't need to be a psychiatrist any more) can fill out one of these forms. Once they do, they are legally immune from any liability or prosecution for whatever they choose to do. They can call in the police and hold you at gunpoint so you can't resist them. If the drugs or combination of drugs they force upon you results in your death, absolutely nothing (in Louisiana) can be done to them. However, federal law violations cannot be negated by Louisiana law. Unfortunately, you need money to "buy justice" and most victims are poor.

This is the latest form. The previous form did not contain the "unwilling" category. Now, if you disagree with whatever a doctor wants to do to you, he can just sign one of these forms - call the police to hold you at gunpoint - and do whatever he wants to you with absolutely no liability under Louisiana law. If you don't find this scary, maybe you should think twice because this is legalized murder.

MEDICINE HAS BECOME A PARALLEL GOVERNMENT

Medicine is essentially a parallel government which operates by its own set of rules. However, these rules are created by doctors - often in secret - and have no relationship to the US Constitution. The US Constitution is the "social contract" which specifies the rights and responsibilities of US Citizens. It is a fair document - if it was actually followed. However, it is not.
