## **INTRODUCTION**

We are taught and most believe the classic stereotypes for doctors and lawyers. We believe doctors promise to "do no harm", lawyers always act in the best interest of their clients, and judges are absolutely fair and impartial. Unfortunately, none of this is true. There is a secret, hidden side to the lives of these people which remains generally unknown to the average citizen. Here, we want to touch on some of the key points of this "hidden world". This is only a small taste of what you quite likely do not know.

## **LAWYERS AND JUDGES**

As a general rule, all lawyers and judges in the US are Masons. Some lawyers are not but essentially 100% of judges are. Having said this, you need to understand what happens when you hire a lawyer to go against someone for some reason. Since both lawyers are Masons, their allegiance is to the Lodge and not to you, the US Constitution or anything else. There is no such thing as lawyer client confidentiality. Everything you say to your lawyer is shared with the opposing lawyer. When the case is settled, both lawyers meet in the secrecy of the Masonic Lodge. All money collected is put on a table and split three ways: one third to each lawyer and one third to the Lodge. That is how it works and how it has always worked.

Criminal court judges are essentially all billionaires. This is not from their salary but from bribes. It is really the only way you can win in most cases. You need to choose a lawyer who is a Mason. He will meet secretly with the judge and they will agree on how much you have to pay. The money is split according to Masonic policy. If you can't pay, you go to jail. However, if you are rich, it does not matter what crime you are accused of - you walk free - guaranteed!

That is how the justice system in the United States really works. Bet you didn't know!

## **MEDICAL DOCTORS**

Long, long ago there were basically two participants in a doctor patient relationship. Those, of course, were the doctor and the patient. However, times have changed. In the past, what transpired between a doctor and a patient remained known to only the doctor and the patient. However, today, essentially everyone knows. Privacy no longer exists. You may not know about EMR - Electronic Medical Records - but it is quite important that you educate yourself ASAP! Electronic Medical Records are *NOT* private [1]. Almost anyone can get them.

Included, unfortunately, are the pharmaceutical companies. They know every prescription your doctor writes. So, when the "detail man" (representative of the drug company) comes to visit your doctor, he knows every drug your doctor has prescribed and this knowledge has consequences for your health. So, say, for example, the detail man comes in and says, "We noticed you are not writing prescriptions for our new drug "Maxprice" but are, instead, prescribing our competitors drug, Pricemax. Now, we are not happy with this. (Pharmaceutical companies spend about \$5000.00 investigating and making a personal file on every doctor) Now, as you know, we are rich and powerful and we have several lobbyists assigned to each member of Congress. I see in your file you have a son. Our investigators report you would like your son to be admitted to Harvard. You know, we can arrange that. However, we won't be able to help you unless you help us. You know, we always help our friends. Consider prescribing our drug, Maxprice."

Now, you know that Maxprice has serious side effects and that people have died. However, Pricemax has a good safety record. But, then, you were taught in medical school that patients are not really people but, instead, are "diseases that walk on two legs". And, you do want your son to go to Harvard. So, you think, "Screw the patients - let them die - my son is going to Harvard!"

### Doctors With Top Secret Clearances

Some doctors have top secret clearances in addition to their medical degree. The most dangerous of these doctors are psychiatrists. I personally interviewed psychiatric medical students at Tulane University who made no secret of the fact that they would all be offered a top secret or "Q" security clearance upon graduation. This is not likely universally true. However, Tulane University is a "gateway" to the mysterious world of the "shadow government" and has links to DARPA, the Pentagon and many other secretive government agencies. Since psychiatrists can order anyone locked away based upon their "opinion" (no hard evidence required) and then do essentially anything they want to them - including murdering them - it is easy to see why such a person would be a valuable asset to the government.

Many doctors have top secret clearances and it would be to your advantage to know if any doctor you see is one of them. In fact, your life could depend upon this knowledge since these people are above the law.

It is highly likely that the mysterious doctor [2] who walked in while Joan Rivers was unconscious in a clinic undergoing a routine procedure by her doctor and performed a different procedure that should only be done in a hospital - which resulted in her death - was a government agent.

### The Charity Hospital Babies

Charity Hospital in New Orleans delivered at least twenty babies to unwed black girls every day - that is 7300 babies per year. These were live, healthy, human babies. Then someone would come in the room with legal documents and tell the girls - teenagers - that, since they could not care for the baby, if they

would sign, they would make sure the baby had a good and a happy life. By signing the documents, the girls gave up all parental rights. As soon as they signed, the baby was taken away - put in a cage - and sold to some research laboratory to be used in experiments. We know this to be true from confidential informants who had access to this facility. It is logical to assume that any "charity type" hospital located in any area with a large black population is doing the same thing.

Charity Hospital has now been replaced with the new and much larger University Medical Center which is "officially" part of Louisiana State University. However, in reality, it is a top secret government facility and is a continuation of the MK Ultra project which never ended but rather continued using different code names and increased security. Before the project even began, scientists boasted that this facility would be "the center for secret human experiments serving all of North America". The security at University Medical Center is incredible using armed guards, facial recognition devices and license plate scanners to name just a few. We assume they are doing all the things that the now abandoned Charity Hospital did, however, with military grade security in place, it is difficult to infiltrate.

Incidentally, the code word for black people in the medical community is "dogs". Obviously, you can't publish a scientific paper admitting you deliberately killed human beings to get your results. So, when you see the word "dogs" in some medical journal in connection with some research project, there is a very good chance the research subjects were black people. For example, we know that Tulane University used black inmates from the Louisiana State Penitentiary at Angola, Louisiana in experiments during the original MK Ultra period and likely afterward. The inmates were promised a full pardon if they consented to the research and survived. Apparently they were unaware that it is standard policy to kill research animals at the conclusion of the experiment. Of course, none survived. Louisiana State Penitentiary is listed as a participating facility in the Church Commission report on project MK Ultra along with Tulane University and Louisiana State University.

## **VETERINARIANS**

There are two options for aspiring veterinarians - become a large animal veterinarian or become a small animal veterinarian. Large animal vets deal with things like cows and horses and generally do not deal with the general public. You are not likely to meet these vets. However, you will most likely meet the small animal vets who deal with dogs, cats and other household pets. Now, these vets need to buy supplies to run their practice. However, since they deal with the general public, the supplier will "encourage" them to also stock and sell meaningless junk like, say, a dog collar with blinking lights so you can see your dog at night. So, even though you are a licensed professional, you are not exactly free to practice as you choose. Here is how this scam works:

The supplier will send "secret shoppers" around to see if you are pushing their "junk" in addition to your normal service as a vet. If you are not, you will be punished economically. Next time you order necessary supplies, the price will go up. And, if you continue to "disobey", the increasing costs could drive you out of business. So, you see, you are actually a slave of some corporation and you are not free

to act according to your best judgment. They probably did not teach you that in school.

## **DRUG COMPANIES**

Drug companies are now the biggest lobby in Congress - surpassing the previous leader which was the tobacco industry. They are vicious competitors and will stop at nothing to win - including murder. They will use any method to win when taken to court. In this excerpt [8], the drug company bribed the attorney representing the opposition to deliberately cause the opposition to lose:

"1994: Kentucky Supreme Court Overturns Verdict for Lilly in Prozac Mass Murder Trial (Fentress v. Eli Lilly). In the early 1990s Dr. Breggin was selected by a consortium of attorneys and approved by an Indiana federal judge to be the sole scientific and medical expert for the common scientific and negligence issues for all of the more than 100 combined Prozac-related cases brought against the manufacturer, Eli Lilly and Company (makers of Prozac®). Specifically, Dr. Breggin was appointed to evaluate for the plaintiffs the scientific basis for the claim that Prozac was causing violence and suicide, and to evaluate the drug company's potential negligence in the development and marketing of Prozac, including any attempts to hide the risk of Prozac-induced suicide and violence. He also evaluated some individual cases for their merit. The first Prozac case to come to trial was the mass murder perpetrated by Joseph Wesbecker at his former workplace, which occurred shortly after he became psychotic on Prozac. The jury was nearly hung but gave a split decision in favor of Lilly.

After the trial, the Kentucky Supreme Court and the trial judge determined that the trial had been fixed between the plaintiff and defendant. Dr. Breggin began to suspect a fixed trial before the trial took place because critical documents were being withheld from him as the expert.

In return for untold millions of dollars, plaintiff's attorney had conspired with Lilly to throw the trial in Lilly's favor. Although profoundly disillusioning to experience the fraud, Dr. Breggin's role as the scientific expert for the combined Lilly cases gave him a unique understanding of how to research and to evaluate product liability lawsuits, including the internal processes of drug companies and the FDA. The story is told in greatest detail in Dr. Breggin's book Medication Madness with multiple citations documenting the fraud." [L1]

Drug companies are in business for profit. If you pose a threat to their profit, you will be attacked. This woman [9] was thrown in jail because she exposed cancer causing agents in vaccines. Actually, she should consider herself lucky because most people who expose the truth about drug companies are killed.

## **VACCINE COMPANIES**

There is legislation in the US making vaccine companies exempt from any lawsuits relating to damage

You see, before this exemption became law, these companies were driven into bankruptcy or nearly so due to lawsuits against them for the injuries their products caused. Basically, it concerns a concept called "Clawback". In this scam, it is actually cheaper to pay for a drug with cash rather than with your insurance card. Using your insurance card can cost much more and the difference is secretly "clawed back" by the company. There have been lawsuits filed based upon the TV investigation.

In order to do the investigation, it was necessary to find a pharmacist who would go on the air and tell the truth about the secret scam on the condition that his identity was concealed. These big companies are quite vicious when it comes to profit and are known to kill informants so this man took on an extreme risk by going public.

## **THE FDA**

The leaders of the FDA are people who were previously executives with the pharmaceutical companies. They do not represent your interests. Lower level scientists, not privy to the scam, have detected that clinical trials of proposed drugs were either falsified or never actually took place at all. However, when they report this, they are overruled by higher officials who actually are agents of the pharmaceutical companies who have infiltrated the FDA.
