## **OLDER METHODS**

Surveillance is probably as old as humanity itself. There have always been people who aspire to be "king of the hill" and, to accomplish this, they need to know what others - whom they intend to subvert somehow - are doing and thinking. So, although none of this stuff is new, with the advent of technology, techniques and methods have become greatly accelerated. However, essential basic

principles remain unchanged.

## **Origin of the FBI**

The FBI originated with J. Edgar Hoover, so let's talk about him. Hoover was a librarian. Back then libraries used index cards. If you are old enough, you remember them. Of course, all this has now been replaced with computers. At any rate, Hoover liked index cards. He used index cards to index the dirt his agents were able to gather about other people so that he could intimidate them. This is how the FBI records system originated.

## The Scanners

The operator will give you a sealed, new, deck of cards. He will tell you to open the new deck and shuffle the cards so that they will be in some random order that no one knows - not even you. The cards are stacked just as they came from the box in the new random sequence. The deck is then placed in the scanner. After they have been scanned, the deck will be returned to you and you will be told to spread the cards out on a table, preserving the random order. The picture from the scanner will then be given to you and it will exactly match what you see before you on the table. So, that is the present state of technology in use by the US Post Office.

So, forget about any conception you may have that what you send through the mail in a sealed envelope is private. The Government has a copy and will likely store it forever. Think you can get cute by not putting a return address? Think again. Finger prints on paper can also be scanned and identified as well as your handwriting. Also, if you are actually in a post office, you are being recorded. The age of privacy is over. Forget it. Privacy does not exist!

## **BIOMETRIC TECHNOLOGY**

Biometrics covers a broad range of technologies. We have all heard of facial recognition scanners. However, faces are not all they scan. For example, you may wear a high school or college ring. Although the rings from a particular school may look identical at first glance, they are not. For example, there might be a scratch. One of the letters - like a "P" - might have a dark spot somewhere in the circle

of the letter. The ultra high definition scanners will record this and link it to you. So, even if the scanner cannot see your face, it can see unique characteristics about you like jewelry and so can identify you.

## **MEDICAL TECHNOLOGY**

### DNA

The government has been studying DNA for quite some time and has developed some pretty unique techniques it can use against you based upon your DNA. In case you believe the government does not have your DNA on file, you are wrong because it does. With the advent of Electronic Medical Records, everything about you including your DNA is sent to the government. You have absolutely no privacy concerning your medical history.

Perhaps about fifteen or more years back, there was an interesting article in Nexus magazine concerning a person who was suing the US Government. It appears - so he claimed - that he had fallen out of favor with the NSA and had become what is known as a "targeted individual". Additionally, due to modern virus design technology, it has become possible to create a virus which will only kill one person because it has been coded to seek out that person's unique DNA. Designer viruses can also target everyone in a specific population if that population has some unique, identifiable, DNA trait.

There was an interesting story about a recent US President. The story claimed that agents had to follow the man into the bathroom and use a "pooper scooper" to collect his excrement to prevent someone from obtaining his DNA. It appears that, if you have someone's DNA, with the proper technology you can subtly control that person wherever the person might be.

Designer viruses - such as AIDS - as well as weaponized cancer viruses - are used to attack specific people or specific populations. You can consult these books [1] to get a feeling for the state of the art in such things.

### Medicine has become a covert paradise for the government

The government absolutely loves doctors and hospitals. In general, people trust these places. And, exploiting trusted sources is one of the government's intelligence gathering specialties. You would likely tell your doctor things you would not divulge to anyone else because you have been conditioned to believe that the relationship between doctor and patient is confidential and only you and the doctor will know what was discussed. Wrong! Everything you tell your doctor "in confidence" is sent to the

government under the new EMR (Electronic Medical Records) system.

Also, the government uses doctors to gather specific information about you which can be used as legal evidence against you. They have found that the best way to do this is to interrogate your children when you are not present. For example, they may ask your kid if there are any guns - and if so how many - are in your home. The kid has no idea that his or her answer could totally destroy their life. If the kid says there are guns in the house, this information is immediately sent to the government. If any of the guns are not properly registered, when you leave the doctor and go home your house will be surrounded by the SWAT team. You and your wife will go to jail and your kids will be abducted by child protection. All of your lives will be totally destroyed. ## **X-RAY SURVEILLANCE TECHNOLOGY**

First, let's go over the technical details of the X-Ray scanners used on people at airports. The term "X-Ray" apparently scares people - and it should - because these rays can kill - so they call them "millimeter waves". Anyway, by adjusting the intensity of the beam, you can "peel back" anything protecting the person. You can electronically remove the outer clothes, then the underwear, then view the naked body and even go further inside the body if you wish.

The only difference is that the satellites have much greater power than the gadgets used at airports - however the principle of operation is the same.

## **SIGINT**

SIGINT means "Signals Intelligence" and includes pretty much everything from communicating with ET's to listening to your telephone calls. The official goal is "total information awareness" and this goal

has been pretty much achieved with the completion of the new center in Utah. Every telephone call in the world is intercepted and recorded - all faxes are intercepted and recorded - all computer traffic is intercepted and recorded. And, this information is stored forever. Now, you may wonder, considering the sheer volume of data, how could it possibly be used in any productive way. It would seem you would easily be overwhelmed by the incredible volume of information. Well, to solve this, special search engines have been created to sort through everything and give a user what he may be seeking. Normally, even this would be time consuming unless, of course, you happened to also have a quantum computer - which they do.

## **HUMINT**

HUMINT means "Human Intelligence" and is one of the three original components of the NSA. Human intelligence means you have to have a real live human infiltrating whatever you are interested in who is in contact with his or her controllers at the NSA. There are agents all over the world and this fact is not really a secret.

However, what you may not know is that there is a "humint" agent living in essentially every neighborhood in the United States. This person - usually a family - has some routine job as a cover so he can blend in with the other neighbors. Obviously, his main concern is to never be identified or "outed" as what he really is because that would essentially nullify his mission. His goal is to remain and be accepted as a person who is as normal and ordinary as possible.

## **PROFILING**

People are profiled from childhood. Although a person's "official" FBI file begins with the high school principles "Confidential Statement" - which is compiled for every student - actual profiling begins much earlier. If your child goes to day care, nurses or social workers compile data. Testing in grade school provides information about your personality. As soon as you get a smart phone, the flood gates of information about you are open wide and everything is recorded and sent to the government. Your teachers are instructed to observe behavior which might indicate you will become a terrorist in the future and report you so you can be put on a secret "terrorist watch list". If you talk about the US Constitution or claim you have "constitutional rights", you will be placed on the terrorist watch list.

You live in a dual world. There are two separate realities operating here. Most people spend their lives in the lower or ordinary reality. However, there is a completely different top secret reality. As you grow up, you will be secretly screened to see if you are a candidate to be invited into this secret reality.

The serious screening will occur in college. Professors who have top secret clearances will watch you. If you seem like a candidate, they will subtly test you. You may be given some confidential information to see how you respond. If your response is favorable, you will advance toward acceptance. Of course, at this stage, you have no idea that there is a completely different world protected by secrecy. Most people will never see this world or even realize that such a thing exists. They will get some ordinary job and have a fairly conformable lifetime. However, if you pass all the secret screening tests, you will eventually be approached and asked if you would like to enter this "other world". You must freely choose this. If you do, you can never go back. This is a lifetime commitment. There is no way out.

## **ADVANCED ASTROLOGY**

You may have seen the feature film, "Minority Report" [3]. The theme is to predict crimes that have not yet occurred and arrest people for things they have not done but are predicted to do in the future. There is similar technology in use today.

### Psychics

The US Government has a secret group known as the "Psy Corp". Other governments most likely do the same thing. Anyone who can travel to the Astral Plane can learn to see the future - and the past. The government uses these people to predict things that have not yet happened but will happen so that they can get a "heads up" on future events.

### Remote Viewers

Remote Views are also taught to view the past and future. However, their main job is to project into the past to solve crimes by "viewing" them as they occur. A good book on exactly what these people are taught and how they do what they do is "Psychic Warrior" by David Morehouse. He was kicked out of the program because he was simply "not evil enough" to fit in with the other viewers. ### Astrology

## **TRANSPORTATION MONITORING AND CONTROL**

Today's cars control you more than you control them. No vehicles manufactured in the US from 2013 and beyond are safe. Originally, they just monitored your location and sometimes bugged your vehicle so the government could listen to "private" conversations. However, today your vehicle is under total government control. You may not notice the square box above the rear view mirror. It was never there before. It contains the electronics. What does it do? (1) Transmits your location. (2) Coordinates with the GPS location and reports if you are speeding. (3) Monitors and transmits any conversations in the vehicle. (4) Enables the government to take total control of your vehicle. For example, if the government wants to kill you, they can lock you inside the vehicle, accelerate to maximum speed and crash the vehicle into a tree or other solid object which will kill you. This is usually done late at night on a secluded road and is reported as a "freak accident". Also, a self destruct feature can cause your vehicle to explode.

The British seem to be at the forefront of vehicle control with their "electronic fence technology". An electronic fence is invisible. However, if you dare cross it, your vehicle will be immediately disabled, the police will receive a notification and you won't be able to go anywhere until the police arrive - investigate you - and electronically clear your vehicle to resume normal operation.

The future holds more draconian surprises. For example, wherever you are, if you exceed the speed limit - even though no one is anywhere near you - you will automatically get a speeding ticket based on the GPS location information and the known speed limit wherever you may be. Also, this information will automatically be sent to your insurance company.

Now, just to sweeten the pot, you no longer own your vehicle. What you bought was just a license for your exclusive use of the vehicle for normal transportation. Everything else is the property of the manufacturer and is protected by copyright. That means that only a licensed dealer has permission to do anything to "your" vehicle other than to routinely drive it. All tools required to do anything are proprietary and you need a license to possess them and only licensed dealers can get such a license. So, if you attempt to do any maintenance on "your" vehicle, you are in violation of the manufacturer's copyright and you can be prosecuted. Also, since the vehicle is controlled by copyrighted software, you are not allowed to know what it is - what it does - or how it works. If you try to find out, you can be arrested and jailed or heavily fined. All you can do is drive. Anything else is now a crime.

## SMART METER PROGRAM

The "smart meter program" is still in its infancy as it is methodically being rolled out across the United States and some other countries. It will take some time to fully implement the program. However, when that day comes - and it will - your life will be a living nightmare. Half of the cost of this program is being paid for by the US Government. This should give you a hint about what is to come. The remaining cost is being added to your monthly electric bill and is generally itemized as "infrastructure improvement charge".

When totally implemented, this is what you can expect:

1. All your household appliances will be "smart appliances".
2. The smart meter will send out an interrogation signal and each appliance will report and identify itself complete with its serial number.
3. Everything in your house will be constantly monitored.
4. You will not be free to use any electrical appliance without permission from the power company. Turning on the appliance will only send a request to operate to the company. Unless approved, the device will not operate.
5. You will be charged a variable rate which will depend on what time of day you use anything in your house - assuming you are given permission to use it at all.
6. All power to your home can be shut off completely at any time by remote control.
7. Eventually, a profile will emerge of your daily routine which will be sent to the government.
8. If you go on vacation, this will be logged and reported to the government.
9. And, best of all, guess who is going to pay the cost of keeping you under twenty four hour surveillance. You are, sucker!
